

Terms and Conditions for Online Payment

The Terms and Conditions contained herein shall apply to any person (“**User**”) using the services of **COREDROID TECHNOLOGY** for making payments through an online payment gateway service (“**Service**”) offered, through website i.e. <http://www.coredroidtech.com/payments> Each user is therefore deemed to have read and accepted these Terms and Conditions.

Eligibility:

You represent and warrant that you are competent and eligible to enter into legally binding agreement and have the requisite authority to bind the other party to this Agreement. You shall not use this Site if you are not competent to contract under the applicable laws, rules and regulations

Modification of Terms and conditions of Service:

COREDROID TECHNOLOGY may at any time modify the terms and conditions ("Terms") of the Service without any prior notification to you. You can access the latest version of the Terms at any given time. You should regularly review the Terms. In the event wherein the modified terms are not acceptable to you, you should discontinue using the service. Settlement of Disputes

Unresolved disputes or differences shall be referred to a Sole Arbitrator to be appointed/nominated by **Coredroid Technology**. The arbitration shall be governed by the (Indian) Arbitration and Conciliation Act, 1996 and any

modifications thereon and rules made thereunder and the law governing the same shall be Indian Laws. The Seat of arbitration shall be at New Delhi or at the sole discretion of the **Coredroid Technology**.

Force Majeure

Coredroid Technology shall have no liability to you for any interruption or delay in access to the Site AND service irrespective of the nature of the cause.

Waiver and Severability

The failure of **Coredroid Technology** to exercise or enforce any right or provision of the Agreement shall not constitute a waiver of such right or provision. If any provision of the Agreement is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of the Agreement remain in full force and effect.
